What are the Important Dates and Times?

- Vendor/Exhibitor Registration cutoff date is August 25, 2019
- Load in date for vendors is Wednesday, September 25th 6:00 p.m. to 9:00 p.m. and Thursday, September 26^{th.} between 6:30 a.m. and 7:30 a.m.
- Event times for attendees is Thursday, September 26th 8:00 a.m. to 4:00 p.m.
- Load out time for vendors is Thursday, September 26th between 4:15 p.m. and 5:15 p.m.

How many attendees / vendors are you expecting?

-This is the first PCC Week event hosted in Wilmington, NC. We expect approximately 150 attendees, speakers and vendors from four North Carolina PCC areas.

Why do people attend this event?

- This is truly a North Carolina Event, with the combined support of four PCCs in North Carolina: Greater Wilmington, Greater Charlotte, Greater Triad, and Greater Triangle.

- We will have four training sessions utilizing USPS and industry experts.

Yes – the venue will be officially open for vendor setup Wednesday, September 25, 2019, from 6:00 p.m. to 9:00 p.m. We will also allow vendors in at 6:30 a.m. on Thursday. Doors open to attendees at 7:30 a.m. on Thursday, September 26, 2019. For the safety and comfort of our guests, we ask that all vendors be setup before doors open Thursday. What time do I have to be out on Thursday?

Will there be WiFi?

Yes.

Will there be electricity?

Yes – but limited. There may be less than one standard 110 outlet per booth. UL approved commercial extension cords are acceptable – cannot extend more than 6 ' into the room. 2019 NC PCC Day at the Coast - FAQ

How many people can I bring with my booth?

With each booth you get two tickets and the option to purchase additional luncheon tickets for \$30 each.

What is the cutoff date for vender registration?

August 25, 2019 – to ensure you are on promotional materials. To ensure we can meet your needs, please register and pay for your booth early.

Is there a loading dock?

Yes. Vendors can load in back of Union Station on 2nd Street. There are carts available to bring your supplies up the service elevator to the fifth floor. Carts must be returned immediately to the loading zone.

Is there any moving equipment?

There are several rolling carts. You can also bring hand carts. If special needs are required, please contact Lori Tucker at Loretta.N.Tucker@usps.gov or (910) 343-5945

Can I tour the facility ahead of time?

What about Parking?

Guests to the College may utilize visitor parking (VP) spaces in Cape Fear Community College Lots L, A and B, as they are available. Please stop at the guard house and the parking guard on duty will direct you to those spaces accordingly. Should the guard be unavailable, please proceed to a space labeled as visitor parking (VP). See maps of Visitor Parking at: <u>https://cfcc.edu/parking/parking-maps/</u>

If all of the visitor parking (VP) spaces are full, paid public parking is available on the street at meters or in the City/County parking decks.

The City Decks are located at 114 North 2nd Street (between Chestnut and Princess Streets) and 115 Market Street (intersection of Market and 2nd Streets). The first ninety minutes is free, \$2.00 starting at hour 2 - \$3 at hour 3, and on until \$10 daily maximum @ 24 hours.

On-street meter rates are currently \$1.25/hour, Monday through Saturday 9 am to 6:30 pm. It is not necessary to feed the meters if you have a state issued Handicap (ADA) placard or license plate.

The Wilmington Convention Center Parking Deck is located on the corner of Nutt and Hanover Streets. The rates for this facility are \$3 for the first hour, \$2 per hour for the second and third hour, \$1/hour thereafter with a \$13 daily maximum.

The New Hanover County (Library) Parking Deck is located at 201 Chestnut Street. The first hour is free with \$1/hour thereafter and an \$8 daily maximum.

Of Note Cape Fear Community College's Nutt Street and Hanover Parking Decks are only open to paid public parking after 5 pm on Fridays through 6 am Mondays. During the week, these facilities are reserved only for employees and students of CFCC. On the weekends, the rate for both decks is the first fifteen minutes free with \$1/hour thereafter and an \$8 daily maximum, payable by debit/credit card only.

Many Downton Hotels are within walking distance to the CFCC venue.
